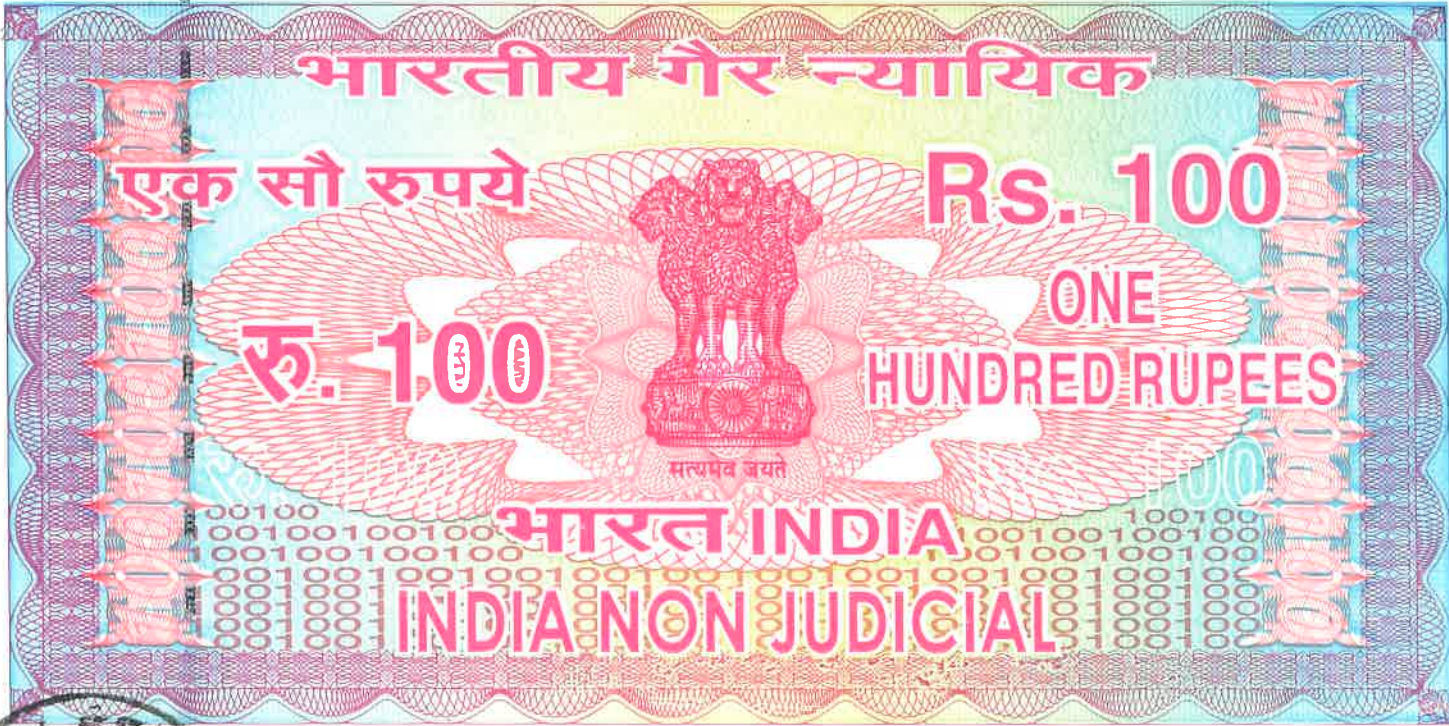

This fifth amendment agreement dated September 9, 2022 ("Fifth Amendment Agreement" or "Agreement") to the Investment Agreement dated December 13, 2014, as amended, among:

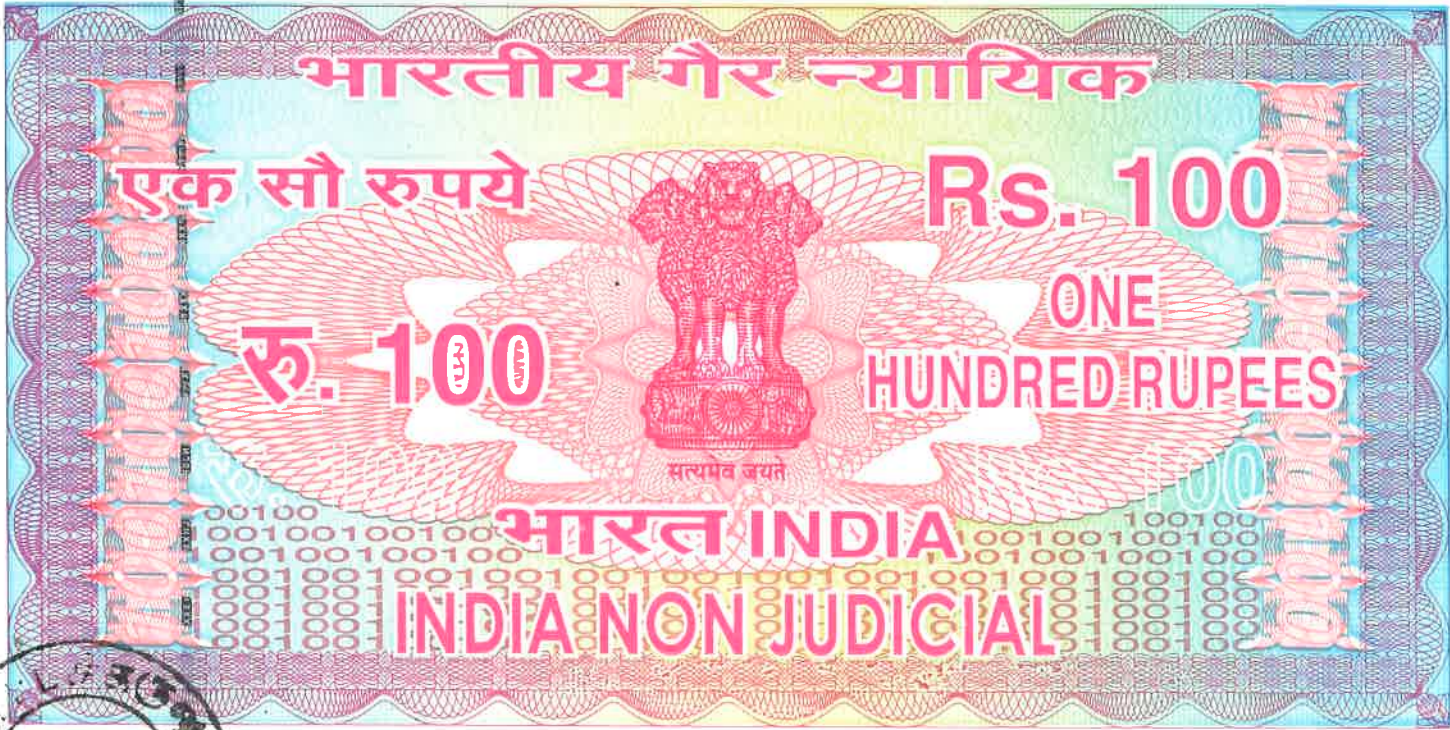
- A. **RADIANT CASH MANAGEMENT SERVICES LIMITED** (formerly known as *Radiant Cash Management Services Private Limited*), a company incorporated under the Companies Act, 1956 and having its registered office at No. 28, Vijayaraghava Road, T Nagar, Chennai- 600017 (hereinafter referred to as the "Company", which expression shall include its successors and permitted assigns), herein after referred to as the **FIRST PART**;
- B. **COL. DAVID DEVASAHAYAM**, son of Major Yovan Devasahayam, aged about 62 years, residing at Plot No.20, 5th Avenue, V G P Golden Beach Part I, Injambakkam, Chennai - 600041, holding Indian passport number Z2634481 (hereinafter referred to as "**Promoter 1**", which expression shall, unless it be repugnant to the subject or context, include his heirs, executors, administrators, successors and permitted assigns), herein after referred to as the party of the **SECOND PART**;
- C. **DR. RENUKA DAVID**, wife of Col. David Devasahayam, aged about 57 years, residing at Plot No.20, 5th Avenue, V G P Golden Beach Part I, Injambakkam, Chennai - 600041, holding Indian passport number Z2825930 (hereinafter referred to as "**Promoter 2**", which expression shall, unless it be repugnant to the subject or context, include her heirs, executors, administrators, successors and permitted assigns), herein after referred to as the party of the **THIRD PART**;

ASCENT INDIA FUND III, through its duly appointed manager, Ascent Capital Advisors India Private Limited, a company incorporated and existing under the Companies Act, 1956 and having its registered office at No.1, Ali Asker Road, Bangalore – 560 052, (“Ascent Capital” which expression shall, unless it be repugnant to the subject or context include its successors and permitted assigns) and Axis Trustees Limited, (“Axis Trustee” which expression shall, unless it be repugnant to the subject or context thereof, include, its successors and permitted assigns) having its registered office at Axis House, Bombay Dyeing Mills Compound, Pandurang Budhkar Marg, Worli, Mumbai 400025 and a Corporate office at The Ruby, 2nd Floor, South Wing, 29 Senapati Bapat Marg, Dadar West, Mumbai -400028, the appointed Trustees of ACA Private Equity Trust, a trust established under the Indian Trusts Act, 1882 and registered with the Securities and Exchange Board of India as a venture capital fund (“ACA PET” which expression shall, unless it be repugnant to the subject or context thereof, include, its successors and permitted assigns), the said ACA PET through its scheme the “Ascent India Fund III” (hereinafter referred to as the “Investor”, which expression shall, unless repugnant to the meaning or context thereof, be deemed to mean and include its legal heirs, successors-in-interest and permitted assigns) herein after referred to as the party of the **FOURTH PART**;

In this Agreement, unless the context otherwise requires:

(i) Promoter 1 and Promoter 2 are collectively referred to as the “Promoters” and individually as a “Promoter”.



- (ii) **Ascent India Fund III** through its duly appointed manager, Ascent Capital Advisors India Private Limited, is referred to as the **"Investor"**.
- (iii) The Promoters and Investor are collectively referred to as the **"Parties"** and individually a **"Party"**.

WHEREAS:

1. The Company, Promoters, and Investor had entered into an investment agreement dated December 13, 2014, which was further amended by amendment agreement dated January 20, 2015 (**"Investment Agreement"**) to record their understanding and agreement regarding their respective rights and obligations under the Investment Agreement.
2. The Company is considering, subject to necessary approvals and market conditions, an initial public offering of its Equity Shares, and proposed listing of the Equity Shares on BSE Limited and the National Stock Exchange of India Limited (together, the **"Stock Exchanges"**) (the **"IPO"** or the **"Offer"**). The Offer may include a fresh issue of Equity Shares by the Company (**"Fresh Issue"**) and an offer for sale of Equity Shares by existing shareholders (**"Offer for Sale"**).
3. In this connection, on September 23, 2021, the Parties have executed a second amendment to the Investment Agreement to (i) amend certain provisions of the Investment Agreement, and (ii) issue and record certain waivers by respective Parties of certain terms under the Investment Agreement (**"Second Amendment"**).
4. Further, on October 8, 2021, the Parties have executed a third amendment to the Investment Agreement to reflect the updated commercial understanding of the Parties in relation to the IPO and Offer (**"Third Amendment"**).
5. Further on June 22, 2022, the Parties have executed a Fourth amendment to the Investment Agreement (**"Fourth Amendment"**) to reflect the IPO Long Stop Date as September 30, 2022.
6. The Parties now desire to further amend certain terms of the Investment Agreement to reflect the updated commercial understanding of the Parties in relation to the IPO and Offer, subject to the terms and conditions as contained under this Agreement.

NOW THEREFORE, in consideration of the foregoing, and the premises, mutual covenants, promises, agreements and provisions set forth hereinafter and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

6. DEFINITIONS, INTERPRETATION AND EFFECTIVENESS

- 6.1. Unless the context otherwise requires, capitalized terms used in any part of this Agreement, to the extent not inconsistent with the context thereof or otherwise defined herein, shall have the same meanings as ascribed to such terms in the Investment Agreement (as amended by Second Amendment, Third Amendment, Fourth Amendment and this Agreement).
- 6.2. The rules of interpretation applicable in terms of Clause 1.2 of the Investment Agreement shall apply *mutatis-mutandis* to this Agreement.
- 6.3. The provisions of this Agreement shall come into effect and be binding on and from the date of execution of this Agreement (**"Effective Date"**).
- 6.4. In the event of any inconsistency between the provisions of this Agreement and any provisions of the Investment Agreement, Second Amendment, Third Amendment and Fourth Amendment, the provisions of this Agreement shall prevail.

- 7.1. Clause 17.5 as amended vide the Third amendment to the Investment Agreement, dated 8th October 2021, is reproduced herein - In the event, the IPO is not consummated prior to the IPO Long Stop Date, then the Promoter 1 shall transfer the Transferred Shares to the Investor within 1 (one) month from the IPO Long Stop Date and Parties agree to undertake all actions, as may be necessary and permissible under applicable law, to ensure the Investor continues to hold 37.21% of the Share Capital of the Company (as held on the Execution Date).
- 7.2. As mentioned in the Third Amendment, Investor had transferred 36,45,121 (Thirty Six Lakhs Forty Five Thousand One Hundred and Twenty One only) equity shares to the Promoter 1 on 1st February 2022.
- 7.3. The IPO Long Stop Date definition under Clause 1.1 of the Investment Agreement, as amended vide Fourth amendment to the Investment Agreement, dated June 22, 2022 is deleted in its entirety and is substituted with the following:
- “IPO Long Stop Date means December 31, 2022 or such later date as may be mutually agreed in writing by the Parties.”

8. REPRESENTATIONS AND WARRANTIES

- 8.1. Each Party represents and warrants, severally and not jointly, and with respect to itself, to the other Parties hereto that:
- i. it is duly incorporated or organized and existing under the Laws of the jurisdiction of its incorporation or organization and that the execution and delivery by it of this Agreement has been duly authorized by all necessary corporate or other action;
 - ii. the execution, delivery and performance of this Agreement by it will not violate any provision of its organizational or governance documents; and
 - iii. this Agreement and any other document to be executed by it pursuant or in connection with this Agreement will, when executed by it, constitute its valid and binding obligations, in accordance with their respective terms.

9. GOVERNING LAW AND DISPUTE RESOLUTION

The Parties hereby agree that the provisions of Clause 32 (*Dispute Resolution*) and 37.4 (*Governing Law and Jurisdiction*) of the Investment Agreement shall apply mutatis mutandis to this Agreement.

10. COUNTERPARTS

This Agreement may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument. The delivery of signed counterparts by facsimile transmission or electronic mail in “portable document format” (.pdf) shall be as effective as signing and delivering the counterpart in person.

11. MISCELLANEOUS

- 11.1. The provisions of Clause 35 (*Notices*) of the Investment Agreement shall apply *mutatis mutandis* to this Agreement.
- 11.2. This Agreement shall not be modified or waived except in writing executed by all Parties to this Agreement.

Save as agreed in this Agreement, all other terms and conditions of the Investment Agreement shall remain unchanged and shall continue remain in full force and effect and binding on the Parties.
